The complainant (victim's father) reports that his daughter was subjected to the fondling of her legs and vagina by the defendant, a neighbor with whom the complainant entrusted with the victim's care for the night.

In a sworn, video taped interview, the victim said she had gone to the defendant's residence to spend the night. She stated that at approximately 0500 hours, while sleeping on the defendant's sofa, she awoke to discover the defendant sitting on the sofa, rubbing the victim's legs and vagina. She said when she realized what was happening, she closed her legs together and rolled over - causing the defendant to stop the activity. The victim later disclosed this information to a school friend and then to her parents.

The above stated information is supported through the sworn, video taped interview with the victim and the sworn, audio taped interviews with her parents.
