

being a sexual offender. The argument turned physical shortly thereafter. The victim stated the def blocked her way refusing to allow her to leave. The victim instructed the def several times to let her go but he would not keeping her against her will. The victim grabbed her cell phone telling the def that she was calling the police. The def responded by snatching the cell phone from the victim along with her car keys and threw them across the room thus depriving the victim access to help from law enforcement. The victim was pushed in the chest by the def causing her to fall over a coffee table. The fall resulted in minor injury to the victim's knee. The victim stated that she is in fear for her safety as the def has stated that a restraining order is nothing more than a piece of paper and has made comments about burning down his old bossess business. Pursuant to Florida State Statute 938.27, the investigative costs incurred by this agency is \$221.00.
